He practiced law with the firm Fried, Frank, Harris, Shriver & Jacobson until 1984 and then, until 2001, held the following foreign policy positions: U.S. Representative in the UN Human Rights Commission, Deputy U.S. Representative in the UN Security Council, with the rank of Ambassador, Assistant Secretary of State for Human Rights and Humanitarian Affairs and Special Assistant to the President and Counselor on the National Security Council. He now chairs the Board of Directors of the American Jewish International Relations Institute. He is married to Lilo Schifter. They have four children, ten grandchildren and nine great-grandchildren.


