Gabriel Steinhardt

Gabriel Steinhardt was elected President of the Jewish Community of Lisbon (Comunidade Israelita de Lisboa) for the 2016-2018 triennium on June 5th, 2016.

Steinhardt is a businessman who served as Managing Director of several international companies in Portugal and in Spain. His professional background also includes Board of Director-level membership in business associations in both countries.

He is fluent in English, Spanish, French, Hebrew and Portuguese. He lived in Israel from 1975 to 1990 and has an in-depth knowledge of Israel related issues, through his experience as a spokeman in media and public relations. He has been elected twice for the Board of Directors of his community, under two different presidents.

She was executive director and lecturer in the postgraduate degree in Cultural Management for Cities at the Institute for Business Management Development - INDEG/ISCTE (2001-2004), State Secretary of Culture (1997-2000), Deputy Minister of Culture (1995-1997) and co-founder of Fórum Dança Cultural Association, acting as Chief Executive (1991-1995).
